- 1. The Member Secretary requested the Governing Body for installation of two 1.5 ton window Air Conditioners and a fridge in the staff room of the college. The Governing Body approved the installation of two 1.5 ton window ACs and a Refrigerator (260 L) in the staff room.
- 2. The Member Secretary informed the Hon'ble Governing Body about relieving of Mr.I.K.Mishra, S.O.(Accounts) to join Bharti College (University of Delhi) on lien basis and

- 3. The Member Secretary placed a note sheet dated 22.4.2019 regarding transfer of Rs.3 crores from Students' Fund Account as loan to meet out the salary expenses to teaching and non teaching staff for the months of April and May, 2019. The Hon'ble Governing Body approved the transfer of Rs.3 crores from Students' Fund Account as loan and the same would be taken back in Students' Fund Account as soon as the grant-in-aid is received by the college.
- 4. The Governing Body approved the name of M/s. Padam Chand, & Co.Chartered Accountant as Internal Auditor to audit the college accounts for the financial year 2018-2019 who is in the University panel vide University letter bearing No. CB.II/263/PoA/AM (01)/2018/403 dated 10.8.2018.
- 5. The Governing Body approved in principle the opening of kiosk of Mother Dairy and NESCAFE.

The college informed that there is a need to have such a kiosk in college premises to deliver healthy and hygienic products among students. As per the proposal from Mother Dairy., there will be no financial liability on college. The college will only have to provide 10x10 feet space in the college. Mother Dairy will bear the expenses of the electricity and Rs.2,000.00 as maintenance charges per month. They will follow the safety and security norms of the college.

- 6. The Governing Body resolved that the Committee of Renovation of College Hall should submit the updated report and the process be done for renovation of college hall as per GFR (GeM or e-tendering).

The Governing Body resolved to expedite the process for the above 11 courses especially B.A.(Hons.) (Political Science) and B.A. (Hons.) (English).

8. The Member Secretary informed the Hon'ble Governing Body that the process of contract appointments of non teaching staff was taken up by the college. The earlier Governing
