 norms and procedure
- 4. The financial implication due to filling up of these posts if any, should be reflected in the R.E for the current financial year 2015-16.
- 5. Reservation policies in respect of posts as per statutory requirements shall be applicable according to the Delhi University norms.
- The Governing Body and Principal concerned shall ensure the posts shall be filled strictly
 in accordance with UGC norms and in the manner as prescribed by UGC Delin
 University.
- All the 100% funded colleges shall intimate to DHE, the outcome/status of the selection process latest by 31/8/2015 alongwith the vacancy position dufy approved by the Governing Body.
